Policies

Make-ups—There are no make-ups

Refunds: 100% before registration deadline, with a \$5 processing fee. 75% after the first week 50% after the second week of classes. No refund after third class. Re-fund requests must be in writing.

Class Cancellations: We reserve the right to cancel an individual class because of a rink conflict. In such a case, a make-up class will be scheduled.

Confirmations: No confirmation calls will be made or letters sent. For on-line registrations your credit card confirmation is a class confirmation.

Class Size: In order to hold a class, there must be a minimum of 3 skaters. If this minimum is not met, we have the right to combine levels or cancel the class.

A \$30 fee is assessed on all returned checks.

What's Included with price of lessons?

- ◆ Lessons each session will be conducted over a 7, 6, or 5-week period by Professional Skating Coaches endorsed by US Figure Skating and/or USA Hockey —either a 30, 45 or 60 - minute class. (75 min Advanced classes also available.)
- ◆ Class sizes are 3-6 students per instructor for Snowplow Sam classes; 5-12 students per instructor for Basic 1-Freeskate 6.
- ◆ Skaters are tested during the last class to determine skill mastery and progression to the next level. Certificates are awarded to all skaters. LTS USA certificates awarded to members only. Discount memberships available through LTS for \$10 annually. Patches will be given to all Learn to Skate USA member skaters who pass their skating level.
- ◆ Half-price Northland Ice Center public skate discount cards are included. Practice ice passes for use on LTS available for \$5 per session.
- ◆ Skate rental included free with registration.
- ◆ **LTS requires an annual membership to Learn to Skate USA per guidelines of governing organization. Cost is \$10 per year per skater and will be added to skater registration if not current member.**
